#### ### **\*\*How Tax Exemption Works\*\***

##### 1. **\*\*Eligibility for Tax Deduction\*\***:

- Donations made to UMOJI qualify as charitable contributions under IRS guidelines.
- The fair market value of the donated car or property can be deducted from your taxable income, subject to IRS limits.

##### 2. **\*\*Valuation of Donations\*\***:

- For cars: The deduction is typically the sale price if sold by UMOJI or the fair market value if used directly by the organization.
- For properties: The deduction is based on the appraised market value. An independent appraisal is required for properties valued over \$5,000.

##### 3. **\*\*Required Documentation\*\***:

- IRS Form 8283 for non-cash contributions exceeding \$500.
- Receipt or acknowledgment from UMOJI detailing the donation, including the donor's name, donation date, and description of the vehicle or property.
- For vehicles, IRS Form 1098-C may be issued if applicable.

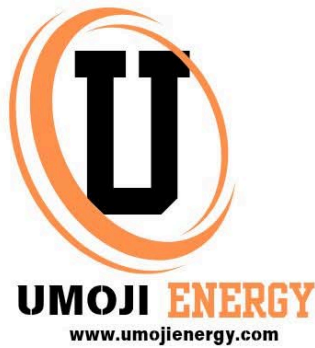
##### 4. **\*\*Tax Filing\*\***:

##### 1. **\*\*Contact UMOJI\*\***:

2. **\*\*Provide Necessary Information\*\***:

- For cars: Vehicle Identification Number (VIN), make, model, year, and condition.
- For properties: Address, size, current use, and any relevant legal or ownership documents.

3. **\*\*Arrange for Transfer\*\***:

- UMOJI will coordinate with you to handle the transfer of ownership.
- For vehicles, UMOJI will assist with title transfer and towing (if needed).
- For properties, UMOJI will guide you through deed transfer and legal requirements.

4. **\*\*Receive Acknowledgment\*\***:

- Once the donation is processed, UMOJI will issue a receipt for your records and tax purposes.
